- Non-bypassable charges shall be all TDU charges and credits for the appropriate customer class in the applicable service territory and other charges including ERCOT administrative charges, nodal fees or surcharges, reliability unit commitment (RUC) capacity short charges attributable to LSP load, and applicable taxes from various taxing or regulatory authorities, multiplied by the level of kWh and kW used, where appropriate.
- LSP customer charge shall be \$0.025 per kWh.
- LSP demand charge shall be \$2.00 per kW, per month, for customers that have a demand meter, and \$50.00 per month for customers that do not have a demand meter.
- LSP energy charge shall be the sum over the billing period of the actual hourly RTSPPs, for the customer multiplied by the level of kWh used, multiplied by 125%.
- The minimum LSP energy charge is 3.44¢/kWh.
